### Finance

<u>Precept 2024/25.</u> The Clerk informed Members that DALC has indicated that the annual subscription will be £274.00 for 2024/25 and that the estimated expenditure by the Parish for the next three months will be just over £3000 with £278.00 VAT being recovered. Members considered all the possible financial implications and unanimously agreed to request a precept of £9000.00. This will be discussed again and the final amount ratified at the January Meeting.
