### **Report from County and District Councillors**

Cllr Davis reported on the Devon County Council Budget 2024/25 which includes increases in children's services, adult services, climate change, environment, transport homelessness, drainage/potholes. Councillors approved a capital budget of over £155million for investment in infrastructure such as schools and roads. She commented on the Public Consultation on Devon and Torbay devolution deal; Devon Retrofit Guide, highways (including A361) and other highways defects. Members asked several questions and clarification on certain items.

The Council now meets six times a year and it was proposed and unanimously agreed to keep holding meetings in Marwood Methodist Church Hall at a cost of £125 a year plus £20.00 for any additional meetings.

### **Reports from Councillors**

<u>Parish Footpaths.</u> Cllr Wallis reported on the work carried out on the footpaths and bridleways for the information to be sent to Devon County Council. He also commented on the overgrown hedges on parts of the highway but it was stressed that the responsibility to cut them is down to the landowner.

<u>Highways</u>: Members commented on the various areas of flooding and the large number of potholes. Some concern had been made concerning the building of a wall on private property. This was inspected by the Highways Officer and confirmed that the wall is on un-registered land and not Devon County Council. The Chairman thanked Angela Webb on behalf of the Council for the detailed report on proposed 20mph areas in the Parish
